Kamdar Homoeopathic Medical College & Research Centre Haripar Pal Survery No.12, Behind NRI Bunglows, Opp. Delhi Public School, Kalawad Road,Rajkot -360007. GUJARAT, functioning since 2017, with intake capacity of 100 seats for BHMS course during A.Y. 2024-25. The college has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfall.

a). Teaching Faculty

• U.G and P.G degree of the faculty is not uploaded.

b). Hospital

 Case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone numbers with complete case analysis, evaluation and repertorisation. These documents and follow up attendance of the patient shall be made available in the medical record room for academic purpose of students.

c). Miscellaneous

- College has not enabled the Aadhar Enabled Biometric Attendance System (AEBAS). Same may be implemented within one month of time.
- Form 16 is not from Traces Portal. Copy of the same may be submitted for verification.
- Web Site of the College is not functional as checked on 3/6/24.

Considering the above observations and facilities available, MARBH has decided to Issue Conditional Permission for functioning with intake capacity of Kamdar Homoeopathic Medical College & Research Centre Haripar Pal Survery No.12, Behind NRI Bunglows, Opp. Delhi Public School, Kalawad Road, Rajkot -360007. GUJARAT 100 seats in UG For BHMS course during A.Y. 2024-25.

All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 100 UG Seats BHMS course shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT Govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if the college is found deficient in Compliance to MSR 2013 anytime during the academic year
